Eligibility



- All international UK alumni from any UK university, on any course, in any year are encouraged to join.
- You need to have spent at least one term at a UK higher education institution enrolled on a credit-bearing course. This includes transnational or online education.

Alumni UK-Indonesia Social Action Grant

- To enable alumni from Indonesia to work together with fellow UK alumni and others to create impact in their own communities
- Activities supports by the Grant must:
- Raise awareness of UK Alumni platform and increase number of sign up to the platform
- 2. Support professional development
- 3. Strengthen UK Alumni networks

- The Grant cover activities which deliver the following objectives:
- Addressing relevant global development challenges faced by communities in Indonesia; OR
- 2. Addressing gender and other equality related barriers in education and employment in Indonesia

Eligibility criteria



- The proposed activities must be led by a UK Alumni from Indonesia who have registered on Alumni UK platform
- The alumni involved in the activities must not be affiliated with any political party.
- The proposed activities are relevant to Indonesia and addressing objectives as detailed in the grant guidance

Funding

- Up to 3 projects of max IDR 60,000,000 (including VAT, if applicable) for a 7-month period of implementation, starting from March 2024
- The Grant Agreement will be signed with the Lead Applicant (Project Lead) who is then wholly responsible for the financial and logistical administration of the project
- Funds will be disbursed directly to the Lead Applicant

- The grant will be paid in Rupiah in two tranches:
- 1. 90% grant agreement signing
- 2. 10% submission of final report (will be based on actual costs)



- Deadline: 29 January 2024, 09.00 WIB, email to <u>alumni@britishcouncil.or.id</u>
- Applications must include:
- Completed application form
- 2. A breakdown of the budget requested (using the provided template)
- 3. A detailed activity plan (Gantt chart), incl. timeline, milestones, division of roles and responsibilities
- 4. A detailed for monitoring and evaluation
- 5. Certificate copy as proof that the Lead Applicant had been studying at one of UK HEI
- 6. Completed bank details form (using the provided template)

Selection process

Activities can be in any discipline or cross-discipline as long as these respond to targeted community needs.
